

**THE CORPORATION OF THE
MUNICIPALITY OF CENTRAL ELGIN**

BY-LAW No. 2026-05

Being a By-law to establish 2026 Fees for services, planning, and development applications provided by the Corporation of the Municipality of Central Elgin and to repeal By-law no. 2526, as amended

WHEREAS section 391 of the Municipal Act, 2001, as amended, authorizes a municipality and a local board to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of it and for various types of licences, permits and approvals;

AND WHEREAS section 69 of the Planning Act, R.S.O. 1990, c.P.13, as amended provides that the Council of a municipality, by-law may establish a tariff of fees for the processing of applications made in respect of planning matters;

AND WHEREAS section 7 (1) of the Building Code Act, S.O. 1992, Chapter 23 as amended provides that a Council of a municipality may pass by-laws requiring the payment of fees on applications for an on the issuance of permits, requiring the payment of fees for maintenance inspections, and prescribing the amount of the fees;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF CENTRAL ELGIN ENACTS A BY-LAW AS FOLLOWS:

This By-law shall be known as the "Fees By-law"

THAT the rates and fees, as outlined in the following schedules attached hereto and forming part of this by-law, be implemented and take effect on January 1, 2026:

Notwithstanding Section 1 of this by-law the rates and fees, as outlined in Appendix 'A' attached hereto and forming part of this by-law, pertaining to Arenas shall be implemented and take effect on June 1, 2026.

THAT for the purpose of this by-law:

'Youth' shall mean eighteen (18) years of age or younger.

'Adult' shall mean nineteen (19) years of age or older.

THAT payment is due and receivable at the time of the transaction for which the fee or charge is imposed, or upon the due date specified in the terms of a contract signed by the Municipality or an invoice issued by the Municipality.

THAT payment of any fee or charge in this by-law shall be In Canadian currency.

THAT fees and charges will be subject to Harmonized Sales Tax (HST) and Retail Sales Tax (RST), where applicable.

THAT fees and charges shall be adjusted annually, on January 1, by the Consumer Price Core Index of the third quarter of the prior year, rounded to the nearest \$0.25.

Notwithstanding Section 6 of this by-law the rates and fees, as outlined in Appendix 'A' attached hereto and forming part of this by-law, pertaining to Arenas shall be adjusted annually, on June 1, by the Consumer Price Core Index of the third quarter of the prior year, rounded to the nearest \$0.25.

Notwithstanding Section 6 of this by-law the rates and fees, as outlined in Appendix 'A' attached hereto and forming part of this by-law, shall not be reduced by the Consumer Price Core Index of the third quarter of the prior year, rounded to the nearest \$0.25 If it decreases.

THAT the Director of Finance shall add unpaid fees and charges imposed by the municipality to the tax roll for the following property in the Municipality of Central Elgin and collect them in the same manner as municipal taxes:

In the case of fees and charges for the supply of a public utility, the property to which the public utility was supplied.

In all other cases, any property for which the owners are responsible for paying the fees and charges.

THAT where this by-law established a fee and charge for a fee that also exists in another by-law that predates the effective date of this by-law, the fee and charge in this by-law shall be the applicable fee and charge and the other bylaw is hereby effectively amended.


THAT should any part of this by-law, including any part of any appendix, be determined by a court of competent jurisdiction to be invalid or of no force and effect, it is Council's intention that such invalid part of this by-law shall be severable and that the remainder of this by-law including the remainder of the impugned appendix, as applicable, shall continue to operate and to be in force and effect.

THAT By-law no. 2526, as amended shall be repealed in its entirety;

THAT this by-law shall take effect on the date of passage by Council.
