**BY-LAW 2559** 

## Being a By-law to Impose Water and Wastewater User Fees and Charges

**WHEREAS** Section 391 of the Municipal Act, 2001, S.O. c.25 as amended, authorizes municipalities and local boards to impose fees or charges on persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and for the use of its property including property under its control;

**AND WHEREAS** the costs included in a fee or charge may include costs incurred by the municipality or local board related to administration, enforcement and the establishment, acquisition and replacement of capital assets;

**AND WHEREAS** a fee or charge may be imposed whether or not it is mandatory for the municipality or local board imposing the fee or charge to provide or do the service or activity, pay the costs or allow the use of the property;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Corporation of the Municipality of Central Elgin hereby enacts as follows:

- 1. That Schedule "A" attached hereto shall be comprised of the list of fees and charges for Water and Wastewater User Fees and Charges By-law for the years 2021 2030 for the Municipality of Central Elgin.
- 2. That By-law 2269 being a by-law to impose Water and Wastewater User Fees and Charges be repealed in its entirety.
- 3. That this By-law shall come into force and effect on March 1st, 2021.

READ a FIRST and a SECOND TIME this 8th day of February, 2021.

READ a THIRD TIME and FINALLY PASSED this 8th day of February, 2021.
